ADDRESS CORRECTION INFORMATION

Postal regulations regarding acceptable forms of address are very important in the delivery of bulk mail; bulk mail is very important to MSERA and our attempts to keep down the cost of mailings. We must, therefore, make sure we are meeting the demands of the post office and the needs of MSERA members.

There are four rules to which we must adhere. These are (a) upper case characters only, (b) omit periods and commas, (c) use standard address abbreviations, and (d) use a ZIP or ZIP+4 code.

Addresses are to be basically three lines: name, address for mail delivery, and city-state-zip. The problem we are running into involves those people who have listed both a street (321 Jefferson Street) or building address (311 Allen Hall) and post office box number (PO Box 333). While your address may have both a street or building address and a post office box number, your mail will be delivered to whichever address is listed in the line just above the city-state-zip.

Therefore, it is very important that you examine your address **in** this directory and your address label **on** this mailing. Please be sure your address is as it needs to be for appropriate delivery.

Please also examine all other information for completeness and accuracy. We are attempting to standardize our record keeping system to ease production of the directory and of mailing labels. Please notify **Joan Butler** of changes.

We are also planning to attempt delivery of the August Researcher through E-mail. If you wish to be a part of this momentous occasion, please be sure we have your correct E-mail address.
